



U.S. Political Engagement Report

Introduction

Salesforce's Government Affairs and Public Policy team advocates for public policies that serve our stakeholders, including our shareholders, customers, employees, partners, communities, planet, and society. Guided by our core values of Trust, Innovation, Customer Success, Equality, and Sustainability, we work with government officials and policy advocates around the world to gain expertise and inform decisions that affect those stakeholders.

Salesforce's Government Affairs and Public Policy team is nonpartisan in our work, and we support policies, candidates, and eligible organizations of any party who share our priorities. Salesforce is transparent, publicly disclosing all contributions in the U.S. in reports filed with the Federal Election Commission (FEC) and with various state campaign finance commissions. Salesforce also participates in a variety of industry organizations, coalitions, and trade associations to advance our public policy interests and business goals. We review these memberships at least annually. We are committed to complying with all laws, rules, and regulations relevant to our political activity. The Political Engagement Report is updated twice yearly and published on <https://www.salesforce.com/company/public-policy/>. The most recent update was December 15, 2025.

Contribution Eligibility

Salesforce is nonpartisan. We support candidates and eligible organizations of any party who share our priorities, even if we don't agree on every issue. All political contributions are made to promote the interests of the Company, without regard for the private political preferences of individual employees.

The Company does not use corporate funds or resources to support U.S. federal candidates and exclusively uses the Salesforce, Inc. Voluntary Political Participation Network PAC, as required by federal law. Where permissible by law, we contribute to state and local candidates as well as ballot measures through corporate expenditures. We also make corporate expenditures to support our membership in trade associations and contribute to other tax-exempt organizations, which may be used for political purposes.



Our policies on, and oversight of, political spending are applied globally and in accordance with the applicable laws and regulations in the jurisdictions in which we operate.

Political Action Committee (PAC)

The Salesforce, Inc. Voluntary Political Participation Network PAC* was incorporated in 2012. Salesforce's nonpartisan PAC is funded entirely by voluntary donations by eligible Salesforce employees. Employees are not reimbursed directly, through compensation increases or any other means, for personal campaign contributions. The PAC supports candidates and eligible organizations of any party that champion our policy priorities, represent and engage with a significant number of our employees, or lead policy-making on issues that impact our business.

The Salesforce, Inc. Voluntary Political Participation Network PAC is governed by an internal steering committee. The Political Contribution Committee is made up of members of the restricted class who are nominated and approved by the Executive Vice President for Government Affairs, in consultation with appropriate members of senior management. We are committed to complying with FEC rules and regulations for PAC contributions, and we publicly disclose all PAC contributions in reports filed with the [Federal Election Commission](#), as required by law.

Corporate Expenditures

Although corporations cannot support candidates for federal office, many states allow donations from corporate treasury funds to political candidates and ballot measures at the state and local level. Salesforce makes political contributions to support candidates and ballot measures in a similar manner to the process for PAC contributions. This includes the involvement of our Political Contribution Committee. We abide by the laws of each individual state and jurisdiction in which we do business, and we are committed to complying with their campaign finance rules and regulations. As a general practice, we do not make independent political expenditures or corporate contributions to independent expenditure committees under Section 527 of the Internal Revenue Code (such as Super PACs). However, if we do, we disclose them in this report.



Trade Associations & Social Welfare Organizations

Like many corporations, Salesforce supports a variety of tax-exempt organizations, including 501(c)3 charitable organizations, 501(c)4 social welfare organizations, and 501(c)6 trade associations. This includes using corporate treasury funds to pay for contributions or memberships in these groups. By law, social welfare organizations and trade associations are permitted to use a portion of membership dues for political activities. Some, but not all, of the groups we belong to engage in political activities.

Salesforce also participates in a variety of industry organizations, coalitions, and trade associations to advance our public policy interests and business goals. We do not always support all of the public positions of those associations or other companies that make up their membership. We review the continued appropriateness of maintaining these memberships at least annually. Beginning in June 2022, Salesforce will disclose our government affairs trade association dues grouped by a financial range.

Political Spending Decisions

Our Political Contribution Committee reviews and approves political spending decisions for the Salesforce, Inc. Voluntary Political Participation Network PAC and corporate contributions. The committee includes representatives from business units outside of Government Affairs. Approval of a contribution requires the support of 75% of the committee.

The Executive Vice President for Government Affairs has final authority over all of the Company's political spending. This position reports to the Company's President and Chief Legal Officer. The President and Chief Financial Officer shall approve all political contributions exceeding \$50,000.

The Nominating and Corporate Governance Committee of our corporate Board of Directors is responsible for regular oversight of our political spending.

Lobbying

Salesforce files quarterly reports about our federal lobbying activity with the [U.S. Senate](#) and the [U.S. House of Representatives](#) in compliance with the Lobbying Disclosure Act. In addition, Salesforce files lobbying disclosure reports in each individual U.S. state and local jurisdiction where we engage in lobbying activity, as local laws require. We are committed to



complying with all laws, rules, and regulations relevant to our lobbying activity in all jurisdictions globally.

Board of Directors

The Nominating and Corporate Governance Committee of our corporate Board of Directors annually reviews our political contributions from corporate treasury funds and the Salesforce, Inc. Voluntary Political Participation Network PAC. The Committee also reviews our company policy on political expenditures and payments to trade associations and other tax-exempt organizations that may be used for political purposes.
