



End User License Agreement for the Events Mobile App for Android

This is a legally binding agreement. Please read it carefully. By clicking "I Agree," or installing or using the Events Mobile App software and/or any updates to such software provided by Salesforce, Inc. (the "App"), you, as the user of the App ("You"), agree to the following terms:

1. GENERAL TERMS

Google Inc. may, at any time and without notice, restrict, interrupt or prevent use of the App, or delete the App from your Google devices, or require Salesforce to do any of the foregoing, without entitling You to any refund, credit or other compensation from Salesforce or any third party (including, but not limited to, Google Inc. or your network connectivity provider).
