The entity as set out in the table above (“**Customer**”) has entered into a Professional Services Agreement (“**PSA**”) and Professional Services Data Processing Addendum (“**PSDPA**”, jointly the “**Agreement**”) either by way of signature or by electronic click acceptance with *Salesforce, Inc. having its principal place of business at Salesforce Tower, 415 Mission Street, 3rd Floor, San Francisco, California 94105*, or any of its Affiliates (as defined in the Agreement) (“**SFDC**”). Customer and SFDC are together referred to as the “**Parties**”. Now the Parties wish to amend the terms of the PSDPA as set out in this “**UK Addendum Amendment**”. This UK Addendum Amendment shall be effective as of the last date of the signature of the Parties listed below (the “**Amendment Effective Date**”) unless otherwise stated herein.

This UK Addendum Amendment amends the Schedule 1 of the PSDPA as follows:

1. Modification to section 1.10 Supervision

The last two subsections of section 1.10 Supervision under Schedule 1 of the PSDPA are replaced by the following provisions:

“1.10.4 Where Customer is established in the United Kingdom or falls within the territorial scope of application of the Data Protection Laws and Regulations of the United Kingdom (“UK Data Protection Laws and Regulations”), the Information Commissioner’s Office (“ICO”) shall act as competent supervisory authority.

1.10.5 Where Customer is established in Switzerland or falls within the territorial scope of application of the Data Protection Laws and Regulations of Switzerland (“Swiss Data Protection Laws and Regulations”), the Swiss Federal Data Protection and Information Commissioner shall act as competent supervisory authority insofar as the relevant data transfer is governed by Swiss Data Protection Laws and Regulations.”

2. Modification to section 1.12 Governing Law

The provisions of section 1.12 Governing Law under Schedule 1 of the PSDPA are replaced by the following:

“The governing law for the purposes of clause 17 shall be the law that is designated in the Agreement. If the Agreement is not governed by an EU Member State law, the Standard Contractual Clauses will be governed by either (i) the laws of France; or (ii) where the Agreement is governed by the laws of the United Kingdom, the laws of England and Wales.”

3. Modification to the section 1.13 Choice of Forum and Jurisdiction

The first sentence of the section 1.13 Choice of Forum and Jurisdiction under Schedule 1 of the PSDPA is replaced by the following:

“The courts under clause 18 shall be those designated in the Agreement. If the Agreement does not designate an EU Member State court as having exclusive jurisdiction to resolve any dispute or lawsuit arising out of or in connection with this Agreement, the parties agree that the courts of either (i) France; or (ii) where the Agreement designates the United Kingdom as having exclusive jurisdiction, the courts of England and Wales, shall have exclusive jurisdiction to resolve any dispute arising from the Standard Contractual Clauses.”

4. Modification to section 1.15 Data Exports from the United Kingdom and Switzerland under the Standard Contractual Clauses

The provision of section 1.15 Data Exports from the United Kingdom and Switzerland under the Standard Contractual Clauses under Schedule 1 of the PSDPA are replaced by the following:

“1.15 Data Exports from the United Kingdom under the Standard Contractual Clauses. For data transfers governed by UK Data Protection Laws and Regulations, the Mandatory Clauses of the Approved Addendum, being the [template Addendum B.1.0](#) issued by the ICO and laid before Parliament in accordance with s119A of the Data Protection Act 2018 on 2 February 2022, as revised under Section 18 of those Mandatory Clauses (“Approved Addendum”) shall apply. The information required for Tables 1 to 3 of Part One of the Approved Addendum is set out in Schedule 2 of this PSDPA (as applicable). For the purposes of Table 4 of Part One of the Approved Addendum, neither party may end the Approved Addendum when it changes.

1.16 Data Exports from Switzerland under the Standard Contractual Clauses. For data transfers governed by Swiss Data Protection Laws, the Standard Contractual Clauses also apply to the transfer of information relating to an identified or identifiable legal entity where such information is protected similarly as Personal Data under Swiss Data Protection Laws until such laws are amended to no longer apply to a legal entity.”

5. **Effect of Amendment.** Subject to the modifications set forth in this UK Addendum Amendment, the Agreement remains in full force and effect.

6. **Counterparts.** This UK Addendum Amendment may be executed electronically and in counterparts.
