- Multipliers suffixed with “- D” in the table are referred to as “Domestic Multipliers”. Domestic Multipliers apply only to Customers who have been approved by the carrier. Domestic Multiplier rates and eligibility are determined by the carrier and subject to change at any time at the discretion of the carrier
